## FIRST AMENDMENT TO INDENTURE OF COVENANTS AND RESTRICTIONS OF SHADOW RIDGE ESTATES PLATS ONE AND TWO

This First Amendment to the Indenture of Covenants and Restrictions of Shadow Ridge Estates, made this 23rd day of July, 2007, by and between Johnson-Yust Development Company, Inc. and Shadow Ridge Construction, LLC (hereinafter known as the "Grantors").

## WITNESSETH THAT:

WHEREAS, Johnson-Yust Development Company, Inc. is the original Grantor of the Indenture of Covenants and Restrictions of Shadow Ridge Estates as recorded in Book 4394 Page 387 in the Office of the St Charles County Recorder of Deeds as to Plat One and as to Plat Two as shown on the dedication of said plat as recorded in Plat Book 44 Page 136 in the Office of the St Charles County Recorder of Deeds; and

WHEREAS, Johnson-Yust Development Company, Inc. is still an owner of lots within Shadow Ridge Estates as required by Article XI Paragraph C of those restrictions for the purpose of amending the same; and

WHEREAS, Shadow Ridge Construction, LLC is the owner of the majority of the lots within Shadow Ridge Estates not owned by Johnson-Yust Development Company, Inc. as required by Article XI Paragraph C of those restrictions for the purpose of amending the same; and

WHEREAS, Johnson-Yust Development Company, Inc. and Shadow Ridge Construction, LLC have agreed to amend the Indenture of Covenants and Restrictions of Shadow Ridge Estates.

NOW THEREFORE, in consideration of the premises stated above, Grantors hereby imposes the following Amendment to the covenants and restrictions on the above-described tract of land.

Article V, Paragraph O shall be amended by the addition of the following:

"This shall include a certain detention basin located in the Stonemoor Subdivision referred to as "Outlet A." which is shared by Shadow Ridge Estates. As provided in the agreement reached by the Trustees of Stonemoor and the Trustees of Shadow Ridge Estates, one-third (1/3) of all costs incurred for the operation, maintenance and repair of this shared detention basin shall be borne by the lot owners of Shadow Ridge Estates. The



Stonemoor Subdivision shall administer the maintenance and repair of said detention basin and invoice Shadow Ridge Estates Homeowners Association for it's pro rata share of these costs accordingly."
