I have lived at the lake for over twenty years and have served on numerous committees and clubs. I have learned a lot about different leadership styles both here as well as in my professional career over the years, and it makes me appreciate the time and dedication our prior leaders devoted to the lake.

The renewed passion and enthusiasm our lake members have shown (whether full-time or seasonal residents), has been amazing and just proves that everyone here sees the value in cohesiveness and working toward shared goals of making our lake a great community in which to belong.

- Revenue We need to be creative and challenge ourselves to develop more revenue. We will evaluate models to increase revenue going forward. The lake is a better value than ever before, and it is important that our revenues keep moving that value up.
- Dredging— Lake maintenance will always be an issue and a healthy, well-maintained lake is a common priority for everyone on our board, as well as our members. This is what drives the value of our properties. It is a key issue that we are all very aware of, and the goal is, after having dealt with some of the issues, that we will be better prepared to prioritize the needs and options to accomplish them.

We are all working extremely hard as a leadership team to develop a common vision for the benefit of all.

As your elected board, we encourage your participation and involvement:

- Please sign up and support our committees such as Pride, Water Quality, Activities, the Legend, and the Women's Club.
- Please attend board meetings and bring us ideas and additional resources to utilize and grow!

## **LLPOA Town Hall Meeting Minutes - June 12, 2021**

This year's Spring Town Meeting's main focus was to present the Lakes Fund Ballot and to discuss the reasoning for the amount of the assessment and the need for such a fund. It was our first in person meeting for over a year due to Covid restrictions.

Jimmy Johnson opened the meeting as acting president and started with the pledge of allegiance followed by a moment of silence for members who have passed. He gave special thanks to Mike Hopkins and John Ipsaro for their past years of service to the LLPOA. He then introduced the two newly elected trustees, James Padgett and Bruce Simeone. The newly elected officers were announced as **RICK CONNORS**- President, **JIMMY JOHNSON**- Vice President, **TODD STEINBRINK**- Treasurer, and **DENIS BEHM**-Secretary.

At that time Jimmy turned the meeting over to Rick Connors. Rick thanked the board for giving him the opportunity to be president and said he was very excited about the future here at the lake. He informed the membership how it has been tough year with all the covid restrictions, along with the office staff turnover and asked for members to be patient. He then introduced our new Lakes Director **Chris Kwiatkowski**, who will be focusing not only on the day-to-day operations, but also collection of past dues, and improving communications between the Board, the Office and our members.

A member presented the idea of term limits for trustees, which will be further discussed.

Bruce Simeone and Todd Steinbrink then gave the Board's PowerPoint presentation on the details of the Lakes Fund Ballot to be sent out in July. A summary of this presentation is printed on page 17 in this issue of the Legend, or a request for a copy can be made to the office. \$\sqrt{}\$



# Lake Safety Patrol - Boating Rules

While enjoying the waters of Lake Lorelei, please be sure to follow all Lake Lorelei Boating Rules, some of which are listed, below:

#### **NEW PWC RULE AS OF DECEMBER 2020:**

■ **NO TOWING** by a PWC, at any time! PWC's are to be for <u>RIDING ONLY!</u>

#### **Speed Limits on the Lake**:

- 35 MPH Sunrise to Sunset
- 6 MPH Sunset to Sunrise
- NO PWC operation after Sunset

#### NO Wake - Idle Speed:

- Within 20 ft. of shorelines & docks
- Within 20 ft. of beaches & swimming areas
- Within 100 ft. of LSP boat while displaying flashing, oscillating, or rotating light(s)
- Within 150 ft. of marina ramp & gas pump
- During YELLOW flag conditions
- In ALL coves



#### PROHIBITED Wake-Surfing:

- From 10am to 5pm on Saturdays, Sundays, & Holidays
- Behind I/O's & Outboards

#### **PROHIBITED Multi-Towing:**

- From 10am to 5pm on Saturdays, Sundays, & Holidays
  - Includes skis, tubes, wakeboards & kneeboards

#### **Boat Operation**:

- Counterclockwise (shoreline on right)
- Non-powered watercraft have the right-of-way

#### **NO SWIMMING:**

- From LLPOA docks or shorelines
- From boats on main lake or outside of coves & inlets



#### **Boat Identification:**

- Powered Watercraft:
  - 3" LLPOA Lot #'s displayed on the left & right of your boats, **stern**;
  - 2021 LLPOA Registration Decal displayed on the upper right **back corner**;
  - All ID's to be visible while on the water, a lift, or at a dock
- Non-Powered Watercraft:
  - 3" LLPOA Lot # & LLPOA Registration Decal on top, or visible above waterline

## Lake Life

#### What good are vultures?

Nearly all of us love the charismatic birds-of-prey we have here at the lake such as osprey, red-tailed hawks, and of course bald eagles. These beautiful and majestic birds are easy to love, but what about our most numerous raptor, the vulture?

We commonly see two species of vulture here at Lake Lorelei: the **black vulture** and the red-headed turkey vulture (with wingspans of five and six feet respectively).

In flight, the turkey vulture rarely beats its wings; it soars with an unsteady but graceful teetering motion with its wings in a shallow "V." On the other hand, a black vulture will more often be seen beating its wings in a quick and snappy motion. When it soars, its wings are flat.

These two can frequently be seen together gathered around a tasty meal of dead fish or mammal, and both species serve a vital role in the lake's ecology. By acting as nature's "garbage disposers," these scavengers help keep the ecosystem clean and free of infectious diseases. Amazingly, these birds have such corrosive stomach acid they can ingest meat contaminated with anthrax, botulinum toxin, cholera or rabies and not bat an eye. In fact, a vulture's digestive system is so efficient at filtering contaminants that its poo (unlike human poo) is sterile—free of bacteria, viruses, or fungi.

Many people in Western societies look down on vultures as ugly and disgusting and fail to appreciate their importance. However, that sentiment doesn't hold for every culture. On the Tibetan plateau, vultures are an essential component of any funeral. There, monks prepare the body and place it on a platform to attract the attention of vultures. After the birds have consumed the flesh, the person is considered to have been "buried in the sky." In this way, the deceased loved one has performed one final good deed: offering something to another living creature before going off to rest in the sky.

I don't imagine that funerary practice will gain much popularity here, but I hope the next time you see a group of vultures picking at a bloated, smelly, 40-pound carp that has washed up on the shore, you'll have an appreciation of the service they're doing for us all! &


We were able to meet in the Clubhouse for our June meeting. We welcomed two new members!

## Lakes Fund Presentation - LLPOA Town Hall Meeting, June 12, 2021

The following is the PowerPoint presentation created and presented by Bruce Simeone and Todd Steinbrink.

#### BELIEFS USED TO MAKE THIS DREDGING PROPOSAL

- We all have a responsibility to the Community, no matter where we live.
- We are here because the water is here.
- Everybody is equal and nobody is special.
- Not everything in the community is perfect.
- Just because we struggle with some things, do not let everything else suffer.
- We have a responsibility to each other and the Lake/Water.
- The Lake is man-made. Man-made items require maintenance.
- Tell the truth, plan by recognizing the truth and do your best to live up to the plan.
- Let the past be the past, but learn from it or make the same mistakes again.
- Forge a new future to make that future better than the past.

#### **BOTTOM LINE**

If we are together, Nothing is impossible. If we are divided, ALL will fail.

#### HISTORY OF DREDGING

- The last Partial dredging effort was competed in 1991 (only 23 years after the lake was first filled)
  - Belief We have a responsibility to the Lake / Water
- 30 years later, lake-bottom build-up remains an issue that should have been addressed then for a more permanent, ongoing resolution.
  - ♦ Belief Learn from the past
  - ♦ Belief The lake is man-made. Man-made items require maintenance.
- Several efforts to pass an assessment over the past 5 years have failed for numerous reasons.
  - Belief Let the past be the past. Learn from it.
- A committee was formed in 2018 to provide greater understanding of the scope of the problem, the
  costs and recommendations for resolving our current issues and addressing it proactively for the
  future.
  - Belief Forge a new future and make that future better than the past.
- In 2018 and 2019, significant education was provided to the membership regarding the several methods, costs and ongoing efforts necessary for a successful project.
  - ♦ Belief Everybody is equal, nobody is special.
- The facts haven't changed, and these issues will continue to compound until addressed. Meanwhile, the bottom continues to fill, green and harmful blue algae growth is more common, the e-coli risk is greater and eventually these will harm the existing fish population and everyone's enjoyment of the lake.
  - Belief Let the past be a past but learn from it.
- The Dredging Committee's work has continued, including ongoing research on the most effective dredging method(s), order of operation and funding in preparation for the project.
  - ♦ Belief Tell the truth, plan by recognizing that truth, and do your best to live up to that plan.

#### THE PLAN: EXECUTIVE SUMMARY

In response to the continued desire of the membership, the Board is proposing an assessment designed to "turn on the spigot" for the benefit of funding ongoing maintenance and enhancements to our lakes.

- *Belief We have responsibility to each other and the lake.*
- ♦ Belief Let the past be the past, learn from it or make the same mistakes again.

The current (February 1994) annual dues and subsequent service fees are only marginally enough to maintain current non-water related operations, much less take on any major projects such as dredging or improving the existing water features of our lakes.

♦ Belief – Not everything in the Community is perfect.

Without passing a measure to provide additional funding, the lake bottom and water issues won't get better.

- ♦ Belief Forge a new future to make that future better than the past.
- ♦ Belief The Lake is man-made. Man-made items require maintenance.

<u>If the community wishes</u> to have dredging and other enhancements completed sooner than the next 10 -14 years, the ballot language allows the LLPOA to pledge the approved assessment to borrow the funds necessary to complete dredging *AND* additional projects over the next 3-5 years.

♦ Belief – Forge a new future to make that future better than the past.

A dedicated committee (of no less than 7 members) will control the planning, execution and oversight of the comprehensive enhancement plan.

♦ Belief – Tell the truth, plan by recognizing the truth, and do your best to live up to that plan

The full Board would like the community's support in passing the assessment to create a **Lakes Fund** and form an independent committee to implement a lake enhancement program.

♦ Belief – Forge a new future to make that future better than the past

#### THE BALLOT

The Ballot creates a new dedicated assessment - the Lakes Fund.

Much like the Roads Fund, the **Lakes Fund** is designed specifically and exclusively for lake-water related projects. Eligible uses of the **Lakes Fund** include:

- Dredging
- ♦ Shoreline
- Beach
- ◆ Spillway
- Water quality
- Valves

It asks for an annual assessment of \$300 per membership.

It would further amend the governing document to allow the pledging of the **Lakes Fund** assessment to borrow funds for earlier commencement of the projects.

#### PROPOSED FUNDING

#### TIMING:

The Ballot would create a **Lakes Fund** and allow the LLPOA to begin collection of funds beginning with this fall's billing cycle.

#### THE MATH:

On an annual basis, collecting \$300 from the members will create a cash flow of approximately \$207,000 per year.

#### FINANCIAL:

An annual cash flow of that amount would enable the Fund to borrow up to \$2MM upfront.

#### **RECOMMENDATION TO THE BOT:**

The Dredging Committee has recommended a 3-4 year project plan that would spread out the expense, drawing borrowed funds only as needed, accumulating assessment funds to limit borrowing and reducing interest expense.

#### **ELIGIBILITY:**

Additional <u>eligible</u> projects will only be considered 5 years after the assessment begins.

#### BY THE NUMBERS

If we used the Lakes Fund annual assessment **only as it is collected**, the work would take 13 years to complete the desired projects.

The ability to use the annual assessment cash flow would enable the ability to borrow the funds, in stages to pull the work forward to complete sooner, at less cost (inflation and less silt to be removed), paying off the loans over a 10-14 year period and create additional funds for supplemental projects **AND** provide a permanent funding base for revisiting the dredging needs in the future. Effectively setting up for a dredging cycle every 20 years.

#### The PROJECT TEAM

The **Lakes Fund**, similar to the Roads Fund, would be overseen by an independent committee <u>outside of the Board of Trustees.</u>

The team would consist of dedicated members of the community (to include a chosen team leader and likely members from the Dredging Committee formed in 2018) to finalize planning of methods and timing based upon the significant knowledge gained through the Dredging Committees research over the past 3 years.

• If the task, once planned in detail by the Committee becomes too involved, a potential Project Manager <u>may</u> be required.

The project team will be responsible for:

- Creating and managing the RFP (Request For Proposal) process
- Creating and communicating a Master Plan, much like the bridge work
- Coordinating vendor selection
- Overseeing the budget and completion of all work associated with the project

One member of the Board will be involved with the team as a liaison for the Board and to facilitate, review, and oversee acceptance and payment of all expenses.

The project team will be accountable for:

- On-going, semi-annual communication to the Community and the BOT
- Total clarity of the movement of funds
- Executing the Master Plan, including the timing of that plan, submitted to the BOT

#### GLLWIC (Greater Lake Lorelei Water Improvement Corporation)

They are designated as a 501(c)3 Charitable Organization.

The mission of GLLWIC is to *improve the quality of the water that flows into, through, and out of Lake Lorelei* 

• By Funding effective soil and water conservation projects with grants, community partnerships, tax deductible donations and bequests.

The Commitment from GLLWIC is:

- a) To design and promote a comprehensive fundraising strategy including private donations and grants in cooperation with the LLPOA Trustees.
- b) GLLWIC will hold funds raised in a designated "Dredging Fund" to be dispersed through a 50/50 matching grant as funds are available.
- c) Funds will be provided to LLPOA through the GLLWIC project funding guidelines.

Once the Lake has committed to a specific dredging plan, GLLWIC is dedicated to pursuing a targeted capital funding campaign.

#### ADDITIONAL INFORMATION

Some members have expressed interest in "pre-paying" their assessment, in order to provide increased funds up-front to reduce borrowing costs. If they do "pre-pay", <u>NO DISCOUNT</u> to the amount due will be provided.

This "good-faith, pre-pay" effort is welcomed by the Board. &





**Megan Connors** graduated from Fayetteville-Perry High School this spring. She will be pursuing an education in Dental Hygiene in Cincinnati.





# The Legend Looks Back

#### 1971

#### May/June

- Trustees elected to the Board this year were Kenneth Morse, Arnold Hurley and Robert Eckstein.
- LLPOA offered Lot mowing for \$6.00 \$8.00, or \$30.00 for the season.
- Three lawsuits with seven pieces of litigation were ongoing with American Realty.
- There were strained relations due to various promises made when selling lots unfulfilled. The main lawsuit was over AR defaulting on the Clubhouse mortgage.
- The HOT BUTTON issue of the day was...payment of dues...and there was mention of the coves starting to fill in with silt...
- The menu for the Lake Restaurant included:
  - 2 eggs, ham, toast and coffee for \$1.40
  - Porterhouse steak dinner for \$3.00
  - Ham and Cheese Sandwich for \$.75
  - Milkshake for \$.40

#### July/August

- The Annual Charge for each lot owner was \$48.00. There was a controversy concerning the fee and if it pertained to each member or each lot. Judge John H. Huston ruled that the covenants were written to define charges as 'per each member'.
- The Summer-long Fishing Derby was well under way. The largest catches so far were a 4 lb.-6 oz. bass, a 7 lb. catfish, and a 1 lb.-5 oz. crappie.
- The Entertainment Committee's plans for August and September included a Luau on the main beach, Bingo, a Monte Carlo night. A 50-50 Dance (half country and half ballroom), and monthly potluck dinners.
- 2,026 cars and boats were checked through the security gate over the July 4<sup>th</sup> weekend (Friday, Saturday, Sunday).



#### 1981

#### May/June

- Trustees elected were Ed Fuhrman, James Hicks and Tom Kitchen.
- As of this year, there were 1,230 property owner members, with 316 homes having been built.
- LLPOA recovered \$13,000 from American Realty's bankruptcy proceedings and was in the process of suing the lawyer who represented the lake in 1972.
- American Realty defaulted on the mortgage.
- The issue of the day was trash on the roads...



- The Lake Safety Patrol reported the "Safest Summer Ever!"

- **150** members and their families participated in this year's Beautification & Barbecue weekend... Amazing!
- Women's Club held a flower and plant sale.
- Revisions to Articles III and IV of the Lake Code were published in the issue. Those articles were about member meetings and elections processes.

#### **July/August**

- Dredging began in May of 1991, with the passage of a dedicated and limited assessment vote. The first activity planned was the creation of retention ponds.
- The outside of the Clubhouse was painted by volunteers and the Women's Club donated funds for a new carpet and floor covering. The outgoing President was Kay Haggis.
- Thursday night Bridge was just starting up.
- Activities Committee's planned events were Softball, an August Pot Luck and a September Pig Roast.

#### 2001

#### May/June

- Trustees winning the election were Joe Graham, Kathryn Greene, and Taylor Frazier.
- **Only 70** members and families worked at the B&B weekend. The outside of the Clubhouse was painted...WOW.
- Members in Bad Standing were less than 10% of the total.
- A public restroom at the Marina was approved by the Board.

#### July/August

- There was a "monster" rainstorm the night of July 17th, with both boats and docks being washed down-lake. A part of the spillway bank was washed away and many homes were. Rain gauges measured 5", 7" and 11.75" at different locations.
- 1991 was the first year that lake water was tested.
- The Activities Committee took over running the Clubhouse restaurant as a pub with limited menu items. It was called the "Drop Anchor Lounge".
- The Teen Activity Club planned a "Back-to-School" Dance for August 24th.



## Lakeside Gardening

Gary Hetzell

As we approach July and August, this is a great time to divide and transplant Iris, Peonies, Daylilies, summer Phlox and other perennials that have finished blooming.

Always remember this rule of thumb for pruning flowering plants and shrubs: pruning should be done after flowering is complete - don't wait till fall or next spring or you will be cutting off next year's flowers.

During most of these two months gardeners are enjoying picking veggies and looking at all their flowers which should be at their peak.

There are several methods for preserving your produce to enjoy well into the winter months, first the old reliable canning method which we don't do much of anymore since it is more time consuming than our preferred method of freezing (you can use a food saver vacuum seal machine). Both methods keep produce fresh for very long periods.

Lastly you want to stop fertilizing all roses, shrubs and plants by the end of August to avoid promoting new tender growth that might be damaged over winter. Enjoy your summer yards, and remember - I'm just around the corner to help you if you have questions!

# John Ipsaro Retires from BOT

#### Saying "So Long", but not "Goodbye"



As the saying goes, "there is nothing constant except change." The Lake Lorelei Board of Trustees is experiencing that in this year's election. In addition to Mike Hopkins, John Ipsaro is also retiring from the board.

John and his wife Heather have lived at the lake since 2007 when they spent the night at a friend's house. They quickly fell in love with the area and what became their  $2^{nd}$  home, soon to be their full-time residence. As a lawyer, John had a skill set that was definitely needed and became a board member in 2010. He is currently serving as secretary and has been the liaison to the LLPOA's outside legal counsel.

In looking back, and looking forward, John said the greatest need for the lake is absolutely the lake dredging project. Even though it has been brought before the community in the past, with no success in passing the measure, it is a must for the continued enjoyment of the lake. "Dredging the lake has been my passion since I started on the board. Even though we have failed, hopefully the next board will be successful. It must be done," John said.

"There is a long list of things that have been completed in the last 11 years, among them is the budget which is always tight. "When I joined the board, we were looking at a \$150,000 shortfall on the annual budget. Now we run with an approximate \$50,000 surplus. While this sounds like a lot, for a community our size it is very small. But it is no longer a deficit."

One of things that John also commented on are the renovations on lake properties and the way people take pride in their homes. That, of course, equates to our overall community life and the value of the homes in Lake Lorelei. It is a plus for all of us who live here.

There are new members who will be joining our Board of Trustees, and John's advice to them: "Understand the diversity of the membership. We range from folks with million dollar-plus homes to folks on a fixed income. That diversity can make it very hard to build a consensus, particularly with respect to issues that impact member finances."

John praised outgoing member Mike Hopkins who basically worked full time as an unpaid, highly dedicated, board member. He feels the current structure of the board is good because the work is divided by skill sets (engineers, finance, IT, etc.) He learned in the past years that board meetings have not been well attended, and that makes it difficult to communicate on both sides: from the homeowners to the board and vice versa.

For a mostly complete list (all that he could remember) of projects completed in the last 11 years, just take a look at these items:

- ➤ Gates ("A controversial topic for sure, but installing the gates resulted in over a \$100,000 annual swing in our finances. They have functioned erratically at times and inconvenienced folks at times. But the impact on LLPOA's budget is enormous. And, if you haven't yet, you should check with your insurance agent I get a 15% savings on my HO insurance because I live in a "gated community.")


