NOTICE OF RECORDING OF LAKE LORELEI PROPERTY OWNERS ASSOCIATION, INC. 2022 CODE OF REGULATIONS AND DEED RESTRICTIONS/COVENANTS

WHEREAS, a Judgment Entry Granting Declaratory Judgment amending the covenants provided for in the Final Development Plan of Lake Lorelei Resort Development was recorded on May 20, 1977 in Book 169, Page 811 of the Official Records of Brown County, Ohio; and

WHEREAS, an Amendment to the covenants provided for in the Final Development Plan of Lake Lorelei Resort Development was recorded on January 1, 1978 in Book 5, Page 2 of the Official Records of Brown County, Ohio; and

WHEREAS, an Amendment to the covenants provided for in the Final Development Plan of Lake Lorelei Resort Development was recorded on May 1, 1979 in Book 5, Page 137 of the Official Records of Brown County, Ohio; and

- WHEREAS, the Lake Lorelei Property Owners Association Inc. 2014 Code of Regulations were recorded on March 18, 2014 in Book 436, Page 344 of the Official Records of Brown County, Ohio; and
- WHEREAS, the Lake Lorelei Property Owners Association, Inc. Deed Restrictions/Covenants were recorded on March 18, 2014 in Book 436, Page 374 of the Official Records of Brown County, Ohio; and
- WHEREAS, the Articles of Incorporation for Lake Lorelei Property Owners Association, Inc. ("Association") were filed with the Ohio Secretary of State on April 11, 1967; and
- WHEREAS, the Lake Lorelei Property Owners Association Inc. 2014 Code of Regulations was adopted by the affirmative vote of the Members of the Association; and
- WHEREAS, the Notice of Recording of Deed Restrictions/Covenants and the 2021 Code of Regulations were recorded on October 26, 2021 in Book 512, Page 1042 of the Official Records of Brown County, Ohio; and
- WHEREAS, the Members of the Association affirmatively voted to revise the 2021 Code of Regulations under Article 4 of the 2021 Code of Regulations and replace the 2021 Code of Regulations with the 2022 Code of Regulations, attached hereto as Exhibit "B" (hereafter, the "2022 Code"); and

WHEREAS, the 2022 Code fully supersedes and replaces the 2021 Code of Regulations; and

WHEREAS, a true and accurate copy of the Deed Restrictions/Covenants is attached hereto as Exhibit "A"; and

WHEREAS, a true and accurate copy of the 2022 Code of Regulations is attached hereto as Exhibit "B"; and

WHEREAS, the Deed Restrictions/Covenants and the 2022 Code are binding on all owners of the properties described in Exhibit "C," attached hereto; and

WHEREAS, the Board of Directors wishes to record the attached Deed Restrictions/Covenants and the 2022 Code with the Brown County Recorder's Office in order to provide a uniform and accurate description of the properties that are subject to the Deed Restrictions/Covenants and the 2022 Code;
