WHEREAS, MARRICK PROPERTIES, INC. is the owner of a portion of that certain property situate in the Third Election District of Calvert County, Maryland, more particularly described in Exhibit A attached hereto and made a part hereof (the "Additional Property"), said property being situated within the area described as the Entire Tract in paragraph A of the Recitals to said Declaration; and

2. Said easements, restrictions, declarations, covenants and conditions shall run with the Property, including the Additional Property described in Exhibit A attached hereto, and shall be binding upon all parties having any right, title or interest in the Property or any part thereof, their heirs, personal representatives, successors and assigns, and shall inure to the benefit of each Owner of any Lot and their respective heirs, personal representatives, successors and assigns, and the Association.

3. The capitalized words used in this Amendment to Declaration of Covenants, Conditions and Restrictions shall have the same meaning as those same words as defined in Article I of the Declaration. This Amendment to Declaration of Covenants, Conditions and Restrictions shall, when properly recorded among the Land Records of Calvert County, Maryland, be deemed an annexation of additional land by the Declarant in full compliance with Article II, Section II of the aforesaid Declaration.
