MD Laws On Passing A Stopped School Bus: What To Know Here are the rules for driving through a school zone and passing buses. **This also** applies to dropping off children at the bus stop when the bus is present.

A state law imposes an increased maximum penalty of \$500 for drivers caught on school bus stoparm cameras failing to stop for buses with red lights flashing that are loading or unloading children. This includes being within 20 feet from the front or rear of the school vehicle. You must wait until the lights go off, the arm is retracted, and/or a good rule of thumb is once the bus starts to move..

RECENT UPDATES TO MARYLAND HOA LAWS

Effective October 1, 2022 new Maryland Laws went into effect during General Assembly which will impact all Maryland HOAs:

- 1. A Reserve Study professional (MD licensed architect or engineer) must be hired/paid by each HOA to determine the capital components the association is required to repair/replace, normal and remaining useful life and cost to replace/repair each capital component, and estimated amount of money the association has allocated and must set aside annually to fund these requirements.
- 2. The Study must be completed by October 1, 2023. Estimated costs to date range from \$2,750.00 \$5,000.00.
- 3. Once Reserve Study is completed, the amounts recommended in the Study must be budgeted into the annual

Reserves within 3 years. This MAY require additional assessments for which the new law provides authority, regardless of any in any limit, restriction, or cap assessments in any HOAs governing documents.

- 4. More information will be provided as this process unfolds. Keep in mind that this is a State Mandate with which Highland Manor Board of Directors must comply no matter who is currently serving.
- 5. Another law change requires your HOA hire an attorney to review Rule Violations/Penalties notifications. Under this new law, questioning of a debtor is no longer permitted in small claims under \$\$5,000 not including interest/costs/ fees. For judgments over \$5,000, debtors can still be required to answer such questions. Details to follow as available.
