
The Board is also planning on presenting a new approach to funding the much needed dredging project next year.





Water Quality Committee Report

Chuck Farmer, Chair

The following are the results of Water Quality testing over the summer of 2020. No results were high enough to post warnings.

E coli tests were done twice a month in June, July and August with the following count per 100ml where 235 cfu (colony forming units per 100 ml of sample) rise to warning level.

Algae blooms in June and July became a concern and samples were taken to test labs.

Chris Nietch of the US EPA had a sample analyzed for type at no cost to LLPOA, with a high abundance of Dolichospermum and Microcystis aeruginosa. Both are known toxin producers. Further testing was done to check on Microcystis, the most prevalent algae in Ohio waters.

On June 30th, a hand carried sample was taken to the Celina Water Department Laboratory with the results received the next day of 1.7 parts per billon, 6 parts per billion being the warning level.

A second sample was taken on July 8th and sent to BSA Environmental Services in Cleveland with the results received on July 10th, of 3.4 part per billion.

The BOT was kept advised during the above testing procedures as they and the committee were concerned about the algae blooms, and pictures were put on Facebook so members could see what to look for when going into the water.

As a result of close monitoring and weather conditions, there were no other tests done for toxic algae for the rest of the summer .

Dissolved oxygen and water clarity testing were also done on a monthly basis starting in April and continuing through November. Clarity testing went from 49" in May to 12" in August due to high algae concentrations in the water column. September has seen the usual increase in clarity due to water temps going back down with cooler weather. Highest water temp measured on June 20th, was 86.4F and dissolved oxygen levels were very high at all depths measured due to high concentrations of algae in the water column.

All test results can be seen at the LLPOA office in the Water Quality folder. Our monthly meetings will start up again on the first Monday of the month, March 2021 at the club house or pavilion, at 6pm.

Lake Office Update - Security Gate

Rick Connors, Trustee

Our new gates will be operable here in the upcoming days. Current information is:

- The bar code lane will function as it did previously, utilizing your current bar code on your vehicle. You may notice a slight difference with bar code recognition and an increase in the speed of the gate opening.
- The guest lane and phone pedestal will have some upgraded changes and enhancements.
 - The **4-digit code** that a guest entered at the pedestal to call the lot owner's phone **WILL NOT FUNCTION** with this new system.
 - All the names listed on the pedestal keypad from the previous system have been transferred to the new one. When a guest arrives at the keypad, they will begin to type in the lot owner's name which will then appear on the screen. When the guest presses the owner's name, the keypad will call the phone # that is listed. The owner can then communicate through the pedestal with the guest, and can also press the 9 key on their phone and the guest gate will open.
 - Once the gates are fully functional, we can add an email to the lot owners' names which will give them access to a smartphone app connected to the gates. This app will allow the owner to see who is at the gate and communicate directly with them. This service is in the near future, but not available at this time.
 - There will also be a record/video of everyone trying to enter as they use the keypad.
 - We will continue to have our security staff working the same hours they did previously to help assist visitors at the gate.
 - We anticipate this new gate transition to go smoothly, with as little inconvenience as possible for all of us.
- The office will be reaching out to all owners in the near future so that the gate enhancements can be added including the app on your phone and to correct names and numbers on the pedestal.
- This new system should help to keep unauthorized people from entering our community.
- In addition, we have installed a new camera system at the gates that gives us the opportunity to review any suspicious activities at any time. All gate crashers will be held accountable.





Jane Wyman, President



The Legend Looks Back

November / December issues


1970 – the only newsletter archived for 1970 was the January/February issue.

1980

- The Board of Trustees voted to issue a ballot vote for a dues increase to \$125.00 starting in 1982, with subsequent annual increases tied to the Consumer Price Index. Ballots were to be mailed by December 26th.
- The Activities Committee reported that after a two-year loan of the organ (from Mr. & Mrs. Loren Rawlins) to the clubhouse, they were in a position to purchase a new one.
- The November Country & Western Dance was a success. More will be planned.
- 120 members and guests attended the Community Thanksgiving Dinner on Nov. 27 at 3 PM. Six large turkeys were fully consumed.
- The New Year's Eve dance was being advertised with music by the band 'Smokin' for \$15.00 per couple.
- The new Editor of the then-called "Lake Lorelei Booster", Susan Spradlin, wrote that she and the staff wanted to include community events in the newsletter.
- A pay telephone was installed near the guardhouse for members' convenience (ask a teenager what that is!).
- "For Sale": items in the issue included a 40-channel CB Radio and an 8-person poker table including ashtrays and cover.

1990

- The President's (Ed Fuhrman) report topics included:
 - A marked increase in mailbox vandalism was noted.
 - Aquatics Unlimited was commissioned to analyze and report on dredging; a partial engineering report was submitted to the board, addressing storage of the dredged material on lake property.
 - A new committee was formed to liaison with township, county and state offices, called the Civic Committee.
- Article II of the Code of Regulations was revised and published by the Code Committee.
- The Activities Committee's plans for the New Year included a Pot Luck Dinner in January, a Chili Cook-off in February and a St. Patrick's Day Dance in March.
- Women's Club decorated the Clubhouse on December 6, and hosted a "Tree Lighting" party on December 9, with finger foods donated and a singing group performance.



Fall color

We had some of the best fall color at the lake that we've had in several years. This was due to a fortuitous timing of weather conditions over the growing season.

There are three factors which cause the changing color of leaves in the fall:

First is the continual, predictable change of the length of day and night. As the earth orbits, the sun's apparent height in the sky changes just a bit each day. The earth's axis of rotation is canted 23.5 degrees to the orbital plane and is the cause of our four seasons. As the nights get longer and cooler, the veins that carry nutrients into and out of each leaf begin to be closed off by a layer of cells at its base. Once this layer is complete, the leaf is ready to drop.

Next is the pigments contained in each leaf. Most of us know that leaves are green in color because of the chlorophyll contained. This is the substance which allows the leaf to manufacture sugars using energy received from sunlight, a process known as photosynthesis. But each leaf also contains other red and yellow pigments called anthocyanin and carotenoids, which come to the foreground when chlorophyll production ceases. Fall colors differ from tree to tree and from leaf to leaf due to the varying levels of anthocyanin and/or carotenoids in each.
