- 6. Bulkhead Presentation Jerry Watkins (Project Manager)
  - o 233 linear feet installed for bulkhead repair.
  - o 814 Cap Repairs
  - o 262 washouts with foam repairs
  - o 62 manta rays/ broken tieback repairs

#### 7. Executive Director Report- Rick McGinley

- Audit on POA properties
  - Audit is being done on every single property with association
- o 60 ft of bulkhead installment is scheduled for Atascadera St
- Billish Park agreement
  - Originally the City of Corpus Christi granted the installation of the wells in the park. However, with changes to how many wells we want to place and the irrigation system that is designed with it, the new plan requires city council approval. New plans included:
    - Four wells to be installed,
    - Two water tanks, each with a 120-gallon capacity totaling 240 gallons
    - A recent study confirmed that a flow rate of 80 gallons per minute is sufficient to meet the community's needs.

#### Property Audit

- Noelle reported collection of \$50,000 in assessments and fees to date.
- The review is part of a broader effort to maintain financial transparency and accountability across all subdivisions.

### 8. Treasurer's' Report - George Reed

- Association is tracking very closely to projected budget
- Current income performance stands approximately at \$471,000, aligning well with expectations, and achieved without incurring extra expenses.
- o The Association is currently \$300,000 under budget in terms of spending.

#### 10. New Business:

- Canal Committee Updates:
  - Upcoming Floodgate Study
    - Drew emphasized the need to identify an optimal location for the flood gate and recommended engaging an engineering firm to conduct a professional site study.
    - George affirmed that it is the POA's responsibility to protect its members, and he fully supports moving forward with a study to determine the best location for the flood gate.
  - Prepared an amendment to submit to the TGLO(Texas General Land Office), requesting permission to revise the existing agreement to allow for flood gate installation.

- A proposal for a formal study was submitted to the City but was struck out by TIRZ, halting initial progress. (Tax Increment Reinvestment Zone)
