- VI. PIPOA History- 2010 to Present
- 1. I first attended several ACC meetings in 2010 or 11.
- 2. I attended the last few meetings of the Carlson Board.

3. I attended almost all of the Moore Board meetings except for 6 months in 2014.

4. I continue to attend Board meetings as possible to the present day.

5. I began presenting Island surveys for such things as boat trailers, common area maintenance, trash cans, palm trees, natural thatch roofs on canals, fencing, and the like. A number of these were done at PIPOA request.

6. I had many discussions on these topics with the Executive Director.

7. I served on the ACC for 9-10 months beginning in 2017 and ending in the spring of 2018 to return to work. My monthly duties were to prepare the agenda and comprehensive minutes for the twice monthly public ACC meetings. My daily duties were to review and take pictures of all of the new project applications and then go each lot and review for design repetition, color repetition, unauthorized changes in topography, design matches application, prohibited designs, harmony of design, and best interest of the subdivision. These screenings had to be done quickly so the rest of the ACC could review and approve the design within 3 days assuming I found no discrepancies. Every weekend I surveyed half of the PIPOA to check for projects being constructed without a permit. At the end of the 9 months, I knew the PIPOA like the back of my hand.

7. A 15 year history of active PIPOA interaction is a valuable asset. "The study of history is not to explain the past, but the present."

VII. Why Am I Running?

1. Since each member has two votes, at least 3 candidates are needed to have an election with any meaning.

2. If the election has meaning, more members are likely to vote. If they vote for that reason, the PIPOA will be more likely to receive the votes that are necessary to pass the Seawall provision.

3. If elected, among other things, I would like to see changes that would further improve board, ACC, and compliance transparency. I would like to see a major expansion of FAQS, historical document content, and new information on the new ManageCasa website. Members need to given more than 3 minutes to address the Board at board meetings. All emails to the PIPOA should be answered appropriately.
